

Who's Running Your State Prisons?

It's been a while since we've highlighted the individuals who comprise the top management teams at each state prison in Pennsylvania – the superintendent and deputy superintendents. Since our last article, many changes have taken place...

SCI Albion, Erie County

Superintendent Nancy Giroux

Giroux began her corrections career in 1994 as registered nurse 2 at SCI Cambridge Springs. She was promoted in to registered nurse supervisor in 1995 and to correctional health care administrator in 2002. In 2003, Giroux became deputy superintendent for centralized services. In 2006, she transferred to SCI Albion as deputy superintendent for centralized services. She served as superintendent at SCI Muncy from 2010 to 2013 and was named SCI Albion superintendent in 2013. She is a 2015 recipient of the DOC's Thomas A. Fulcomer Award.



A graduate of Mattatuck Community College in Connecticut, Giroux earned her registered nurse diploma from the Newport Hospital School of Nursing in Newport, R.I. and became board certified in 1982.

Deputy Superintendent for Facility Management (DSFM) Michael Clark



Michael Clark began his corrections career at SCI Albion in 1995 as a drug and alcohol treatment specialist (DATS), and in 1998 was promoted to SCI Albion's DATS supervisor. In June 2006, he was promoted to corrections classification and program manager (CCPM). He was CCPM at Albion until November 2009, at which point he was promoted to major of the guard and unit management at SCI Cambridge Springs. Michael held that position until he was promoted in August 2010 to DSFM at Cambridge Springs. In June 2013, he moved over to DSCS, and in February 2014 returned to Albion as DSCS. In August 2015 he switched to DSFM.

A graduate of Union City High School, Michael attended Mercyhurst College in Erie, Pa., graduating in May 1985. A fairly unknown fact about Michael is that his initial direction in college was voice performance and received a scholarship for this at Mercyhurst. He also played football for the Lakers during his four years there.

Deputy Superintendent for Centralized Services (DSCS) Melinda Adams



Melinda Adams began her corrections career at SCI Cambridge Springs in 1994 as a clerk typist and was promoted to laundry manager in 1998. She transferred to SCI Albion in 2006 as the superintendent's assistant, then was promoted to major of unit management in 2014 and to DSCS in August 2015.

She was a member of the hostage negotiations team at SCI Cambridge Springs and attended fire emergency response team school when appointed to back-up safety manager. Melinda served as a staff trainer for Women Offender's in Pennsylvania Corrections (WOPAC) and Fraternalization, to which she was a member of the committee assigned to develop the training. She served as a program committee member for the statewide Empowerment Symposium for 10 years and has presented various workshops at local, regional and state symposiums and has presented fraternization workshops at the PA Association on Probation, Parole and Corrections and the Juvenile Detention Centers Association of PA and at the PA Prison Wardens Association Conference. She was a 2004 Department of Corrections Outstanding Performance Award recipient.

SCI Benner Township, Centre County

Superintendent Tammy Ferguson

Ferguson began her career at SCI Smithfield in 1995 as a corrections officer. She moved progressively up the ranks. In April 2003, she earned sergeant stripes. Remaining at SCI Smithfield, Ferguson was promoted to lieutenant in 2005 and three years later she was named captain. In May 2009, Ferguson transitioned to Central Office as a central region inspection captain. She remained at Central Office and was promoted to chief of security. Transitioning to SCI Rockview in 2012, Ferguson was named DSCS. When SCI Benner Township opened, she moved to that facility in the same capacity. She was named superintendent of SCI Benner Township in 2014.



Ferguson has served in the United States Air Force and Pennsylvania Air National Guard.

DSFM Gerald McMahon

Gerald was born in Buffalo, NY, yet raised in Huntingdon, Pa., where he graduated from Huntingdon Area High School. His first job ever was cooking steaks at the Big Rangler Steak House. After graduating high school, he joined the U.S. Army. After the military, Gerald worked in New Hampshire as a cabinet maker. He returned to Pennsylvania, where he worked as a cabinet maker at Endres Woods and Plastics in Huntingdon.



Gerald began his DOC career at SCI Huntingdon as a corrections officer 1 in 1987. He promoted to the Quehanna Boot Camp as a sergeant in 1992. In 1993, he made lieutenant and served in that capacity until 1995 when he went to SCI Houtzdale to help open that facility. He served as captain from 1995-2000. In 2000 he returned to the boot camp as deputy commander. Gerald transferred to Rockview in 2003. He then promoted to major of the guard at SCI Cresson and served in that capacity until the prison closed in 2013. He then transferred to SCI Benner Township, where he was major of the guard for four months. He returned to Rockview as major of the guard in 2013. In 2015 he promoted to DSFM at SCI Benner Township, where he presently serves

He was in the DOC's very first CERT Academy, and he graduated from the Pennsylvania Criminal Justice Executive Institute (DOC program).

When asked what corrections position has been his favorite and why, Gerald said, "Shift commander was absolutely the best position I held, because it gave me the ability to manage employees while still being able to spend the majority of my day inside the jail. I enjoyed the staff interaction, and really getting to know the officers on my shift was the best part. In addition, making decisions and the daily problem solving was also very enjoyable and challenging."

If Gerald could have any job in the world, he said he would want to be a high school football coach. "I was a youth football coach for 18 years and plan to coach again after my children finish high school." He said.

DSCS Bobbi Jo Salamon

Bobbi Jo Salamon began her correctional career in 2001 as a primary therapist at the King's County Hospital Center, Forensic Ward, in Brooklyn, NY. In 2002, she entered into the PA DOC as a psychological services associate at SCI Huntingdon. She was promoted to a psychological services specialist in 2004 and transferred to SCI Camp Hill's Diagnostic and Classification Center, in the same capacity, in 2005. Bobbi Jo was promoted to unit



manager in 2007, where she worked primarily with newly received mentally ill offenders.

In December 2011, she accepted a detached duty position at Central Office as a staff assistant for the Central Region deputy secretary. In April 2013 she was promoted to CCPM at the newly opened SCI Benner Township and then, in June of 2014, she assumed the role of acting DSCS at that facility. SCI Cambridge Springs, Crawford County

Superintendent Joanne Torma



Joanne Torma, a native of Beaverdale, Pa., was named superintendent of SCI Cambridge Spring in 2014.

She began her corrections career in 1979 as a part-time ABE/GED teacher at SCI Mercer. After two years she left corrections to attend Pittsburgh Theological Seminary. Upon graduation, Joanne served as a local church pastor for seven years until she returned to corrections as the facility chaplaincy program director (FCPD) at SCI Mercer.

In 1995 she transferred to SCI Muncy as FCPD, where she remained for seven years until she was promoted to the Central Office position of administrator for religious and volunteer services. In 2003 Joanne was promoted to DSCS at SCI Muncy. During her five years there she served as DSCS for 2.5 years and DSFM for 2.5 years. Joanne moved to the Training Academy in the fall of 2008, where she served as the associate director for facilities management until her appointment in 2010 as the director of the Office of Population Management at Central Office.

DSFM Debra Rich

Debra Rich has spent the majority of her 25-year career with the Department of Corrections helping inmates who have mental health and physical disabilities at SCI Camp Hill.



She began in 1990 as a corrections counselor 1 in the Sex Offender Program (SOP). The following year she was promoted to corrections counselor 2, remaining in the Special Needs Unit (SNU) and SOP until 1998 when she moved to the diagnostic center. Early in her career with the DOC, she was selected by the Office of the Victim Advocate to train with the California Department of Corrections for the development of the Impact of Crime on Victims.

Four years later, in 2002, she returned to the SNU and SOP, until her promotion in 2005 to unit manager of that unit, a position she still holds. In the past she served as a member of the institution's hostage negotiation team for 14 years and was eventually team leader. Even before the recent changes in policies and procedures impacting special needs units within all of the DOC's institutions, Debra's SNU offered peer assistants, art and music programs, educational opportunities, recreational activities and re-entry assistance with hard-to-place offenders.

Debra has worked to help develop the Department of Corrections' Certified Peer Support Specialist Program and assists with supervising the program at SCI Camp Hill. She is a member of the institution's mural committee and helped organize the palliative care program. Most recently, Debra and her staff have worked hard to transition SCI Camp Hill's SNU to a Residential Treatment Unit. In addition to this she also supervises the operations of the inmate commissary. She also served as SCI Camp Hill's acting classification program manager from November 2014 to February 2015. In 2015 she was appointed DSFM at SCI Cambridge Springs.

With a positive attitude and professionalism, Debra has demonstrated the ability to manage several busy areas and still offer quality services to staff and inmates alike. She is a role model, willingly accepting additional tasks and assisting co-workers. She is currently a member of the Leadership Development Institute Class of 2015.

Debra holds a bachelor's degree in psychology, with a minor in criminal justice. She also worked part time as a county prison corrections officer and drug and alcohol counselor for community-based agencies, both inpatient and outpatient, before joining the Department of Corrections.

DSCS Daniel Przybrowski

Daniel Przybrowski served in the United States Air Force before coming to the DOC. He began his corrections career as a registered nurse in 1996 at SCI Albion. He left the DOC in 2004 for a little over a year to work as a registered nurse supervisor at the Soldiers and Sailors Home in Erie, Pa.

Daniel returned to the DOC at SCI Cambridge Springs in February 2006 as a registered nurse supervisor. In December 2006, he was named corrections health care administrator. In January 2014, he was named acting DSCS. He officially was appointed to serve in that capacity in June 2014.



A graduate of Punxsutawney Area High School and Clarion University, Daniel is a 2008 graduate of the Pennsylvania Criminal Justice Executive Training Institute and has presented many trainings for fraternization, professionalism and ethics during his career.

SCI Camp Hill, Cumberland County

Superintendent Laurel Harry



Laurel, a native of Waynesburg, Pa., was named superintendent of SCI Camp Hill in 2012.

She began her corrections career in 1996 as a full-time psychology intern at the Federal Correctional Institution in Morgantown, W. Va. Later that same year, she became a drug/alcohol case management specialist in Washington County.

In 1999, Laurel began her career with the Pennsylvania Department of Corrections as a DATS at the State Correctional Institution in Waynesburg. Several years later, she was promoted to DATS supervisor and, for seven months, served as acting unit manager.

She divided her time between SCI Waynesburg, as it was being closed, and SCI Fayette, which recently had opened in Fayette County. In 2004, she was named unit manager at SCI Fayette and transferred laterally to SCI Greene in 2005.

In 2008, Laurel was named CCPM at SCI Camp Hill, a position she held for 16 months before serving as a staff assistant to the deputy secretary for the central region at the department's Central Office.

For more than a year, Harry served as deputy superintendent for SCI Waynesburg and was responsible for overseeing contract negotiations with property owners as officials were contemplating reopening the facility. In December 2010, she was transferred to DSCS at SCI Greensburg. In February 2011, when the decision was made not to reopen SCI Waynesburg, Laurel was appointed DSCS at SCI Graterford.

Laurel graduated with honors from West Virginia University at Morgantown, with a Bachelor's degree in Psychology and a Master's degree in Counseling.

DSFM Barry Smith

Barry was raised in Indiana, Pa., and graduated from United High School. He has attended Indiana University of Pennsylvania.

His first job ever was in dairy farming, and before coming to the DOC, he served on active duty in the United States Navy (serving in the Persian Gulf War). Barry joined the United States Army reserve and served in both Operations Iraqi and Enduring Freedom. Smith retired from the military in 2013 with 22 years of service.



Smith began his corrections career as a corrections officer in 1995 at SCI Houtzdale. Over the years he rose through the ranks while serving as sergeant, lieutenant, captain. He has worked at SCI's Houtzdale, Pine Gove, Forest, Albion and most recently SCI Camp Hill.

He has been a member of the DOC's Corrections Emergency Response Team (CERT), a regional Corrections Rifle Specialist Team (CRST) member and regional Hostage Rescue Team (HRT) member. In 2013, Barry was named major of the guard at SCI Albion. In 2015, he was appointed DSFM.

In addition to his DOC duties, he served as a municipal Police officer and is a 2015 graduate of the Pennsylvania Leadership Development Institute.

When asked what his favorite corrections job has been, Barry said, "He enjoyed working the Leadership Development Program at SCI Pine Grove as a drill instructor."

If Barry could have any job in the world, he said he would want to work with wounded warriors and veterans.

DSCS Shawn Kephart

Following a 20-year career in the United States Navy, Shawn Kephart began his corrections career with the DOC's Bureau of Inmate Services in 2002 as a drug and alcohol program analyst, and later that year he was promoted to DATS supervisor at SCI Rockview. In 2007, he was promoted to corrections classification program manager at SCI Frackville. He was CCPM at Frackville until March 2011, at which point he was appointed as the director of the Bureau of Treatment Services at the DOC's Central Office. Shawn held that position until he was recently promoted in August 2015 to the position of DSCS at SCI Camp Hill.

SCI Coal Township, Northumberland County

Superintendent Vincent Mooney

Mooney began his corrections career as a corrections officer at SCI Dallas in 1985. While at that facility, he earned the rank of sergeant in 1990. Vince moved to SCI Mahanoy when he was promoted to lieutenant in 1993.

In 1998, Vince became an inspection lieutenant at Central Office. He returned to SCI Mahanoy as a captain in 2000 and returned to SCI Dallas as major of the guard in 2005. Two years later he was promoted to DSFM at SCI Coal Township and in the same year he returned to SCI Dallas as deputy superintendent of facility management.



During his tenure at SCI Dallas, Mooney served as interim warden at Lackawanna County Jail. Upon his return to SCI Dallas, he was named as DSCS. He was named superintendent of SCI Coal Township in 2013.

DSFM Ed Baumbach



Ed Baumbach began his corrections career at SCI Camp Hill in 1993 as a corrections officer trainee (COT), and in 1998 was promoted to sergeant. In April 2002, he was promoted to lieutenant at SCI Coal Township. Ed was promoted to captain in November 2005, where he served as intelligence gathering captain and shift commander on all shifts. Ed held that position until he was promoted in December 2013 to major of the guard. In August 2015, he was promoted to DSFM. He served as an instructor at the Training Academy from 1997 to 1998, then again from 1999 to 2001. He has been active in CERT since he was a COT and served as assistant team leader at SCI

Coal Township from 2002 – 2006.

DSCS Tony Lusavage

Tony Lusavage began his career in corrections at SCI Mahanoy as a corrections counselor in 1995. In 2005 he was promoted to unit manager at SCI Coal Township, where he was assigned the Special Needs Unit and Therapeutic Community Housing Unit. In 2007, he accepted a position with the Bureau of Treatment Services as the specialized program coordinator. In 2008, while still at the Bureau of Treatment Services, Tony was assigned to Central Office Psychology as a mental health program manager/corrections evaluation

SCI Dallas, Luzerne County

Superintendent Larry Mahally

Mahally began his corrections career as a corrections officer at SCI Dallas in 1985. He transferred to SCI Mahanoy and was promoted to sergeant in 1993 and then was named lieutenant in 1997.

Larry transitioned to SCI Forest in 2005 as a unit manager. He promoted to captain at SCI Retreat in 2006 and then to SCI Dallas as major of the guard the following year. In 2009, he was appointed to DSCS at SCI Dallas. In 2010, he was named DSFM. Larry was interim DSFM at SCI Retreat in 2013.



He returned to SCI Dallas as DSFM in 2014. He was named superintendent in April 2014.

Mahally is a veteran of the United States Marine Corps and a graduate of James M. Coughlin High School, Wilkes-Barre.

DSFM Joseph Zakarauskas

Joseph Zakarauskas, a graduate of Wilkes Barre School District, began his corrections career as a corrections officer in August 1987 at SCI Retreat. Over the years he rose through the officer ranks having served as a sergeant and lieutenant while at SCI Retreat. In 2005 he accepted a promotion to captain at SCI Dallas, where he served as security captain from 2005 until 2010. In March 2010 he accepted a promotion to major of the guard at SCI Dallas. In August 2014, Joseph was promoted to DSFM at SCI Dallas.



In addition to his DOC duties, while at SCI Retreat, he served as an instructor in various subject matter along with serving as the institution's CERT Team leader. He is a member of the Pennsylvania Prison Wardens Association and a former member of the National Gang Crime Research Center, where he was certified in corrections gang and security threat group intelligence, along with management and gang supervision for gang specialists.

DSCS Norm Demming



Raised in Scott Township, Pa., Norm graduated from Lakeland High School. In 1993, he was promoted to corrections inmate vocational/employment coordinator and, in 1994, to unit manager at SCI Albion. He was a unit manager at Albion until 1999, at which point he was promoted to major of unit management. Steven held that position until he was promoted in August 2002 to DSCS at SCI Laurel Highlands. In June 2004, he moved to SCI Somerset as DSFM, and in 2008 moved to SCI Fayette where he

DSCS Eric Armel

DSFM Jeff Horton



On January 21, 1987, Jeff Horton was hired as a corrections officer trainee at SCI Graterford. He spent his first several years as a block officer and then he was assigned to the restricted housing unit for a few more years. In April 1992, he was promoted to sergeant and assigned to work C-Block. At the time there was no special needs units, so C-Block was the block that housed many of the mentally ill inmates.

From April 1993 until June of 1993 he was assigned to control as a shift sergeant. This was a hectic job, as we all know this is the nerve center of the facility. He took a voluntary demotion to corrections officer to transfer to SCI Cresson so he could be back close to home. He was promoted to lieutenant at SCI Somerset in February 1994. He was assigned to the 2-10 shift as a shift lieutenant. He had a zone of responsibility, which included L-2 housing unit, visiting room, receiving & discharge and property.

He transferred from SCI Somerset to SCI Houtzdale as training lieutenant in August 1995 and was promoted to captain at SCI Houtzdale on June 12, 2000. For the next eight years he worked all the shifts as shift commander and several times as acting major. Jeff was promoted to major of the guard on February 3, 2008, at SCI Houtzdale and held the position until October 2010. At that time he was promoted to deputy superintendent 2 at SCI Rockview. 
DSFM David Zetwo



Something most people don't know about Bill is that he is a huge supporter of Title 9 and highly encourage women/girls to participate in sports.



Superintendent Jack Sommers
