Recognizing the importance of reliable data for effective planning and evaluation efforts, the Department is committed to the ongoing development and refinement of our information systems and the corresponding published data reports. These efforts are being continuously undertaken in order to provide policy makers and correctional administrators with the timely and accurate data necessary to effectively manage the Department's nearly 15,000 employees, 26 prisons, 14 community corrections centers, one motivational boot camp, and more than 40,000 inmates.

We trust that this annual statistical report will serve to increase your understanding of the state prison system, its inmate population, and the significant challenges which the Department as well as Pennsylvania's entire criminal justice system are addressing.

Receptions

Overview

The total number of receptions to the Department of Corrections (DOC) increased by 7.9% from 11,673 in 2000 to 12,593 in 2001.

Court commitments comprised 59.6% of receptions, an increase of 4.3% from 7,203 in 2000 to 7,510 in 2001.

Parole violators constituted 39.3% of receptions, an increase of 14% from 4,348 in 2000 to 4,955 in 2001.

Philadelphia County, Allegheny County and Dauphin County accounted for 46.5% of all new court commitments in 2001. In 2000, these three counties accounted for 49% of all new court commitments.

Male court commitments increased by 3.7% from 6,680 in 2000 to 6,924 in 2001, while female court commitments increased by 13.8% from 523 in 2000 to 586 in 2001.

Court commitments for offenders under age 18 decreased by 21% from 43 in 2000 to 34 in 2001.

Offenses

The Department experienced changes in the type of commitments received from 2000 to 2001 including the following:

Court commitments for Part One offenses decreased by 2.9% from 2,940 in 2000 to 2,854 in 2001, while commitments for Part Two offenses increased by 9.5% from 4,239 in 2000 to 4,641 in 2001.

Court commitments for First Degree Murder decreased by 3.2%, Second Degree Murder increased 9.5%, while Third Degree Murder decreased by 14.4%.

Drug commitments increased by 7.1% from 2,311 in 2000 to 2,475 in 2001 and account for over 30% of all new court commitments.

Sentence Length

The Department experienced only minor changes in sentence lengths from 2000 to 2001.

The percentage of new court commitments sentenced to a minimum sentence of 2 years or less increased slightly to 57% of all new court commitments in 2001, compared to 54% of all new court commitments in 2000.

The number of new court commitments serving a maximum sentence of 10 years or less remained relatively constant at 85% of all new court commitments in 2001, compared with 84% of all new court commitments in 2000.

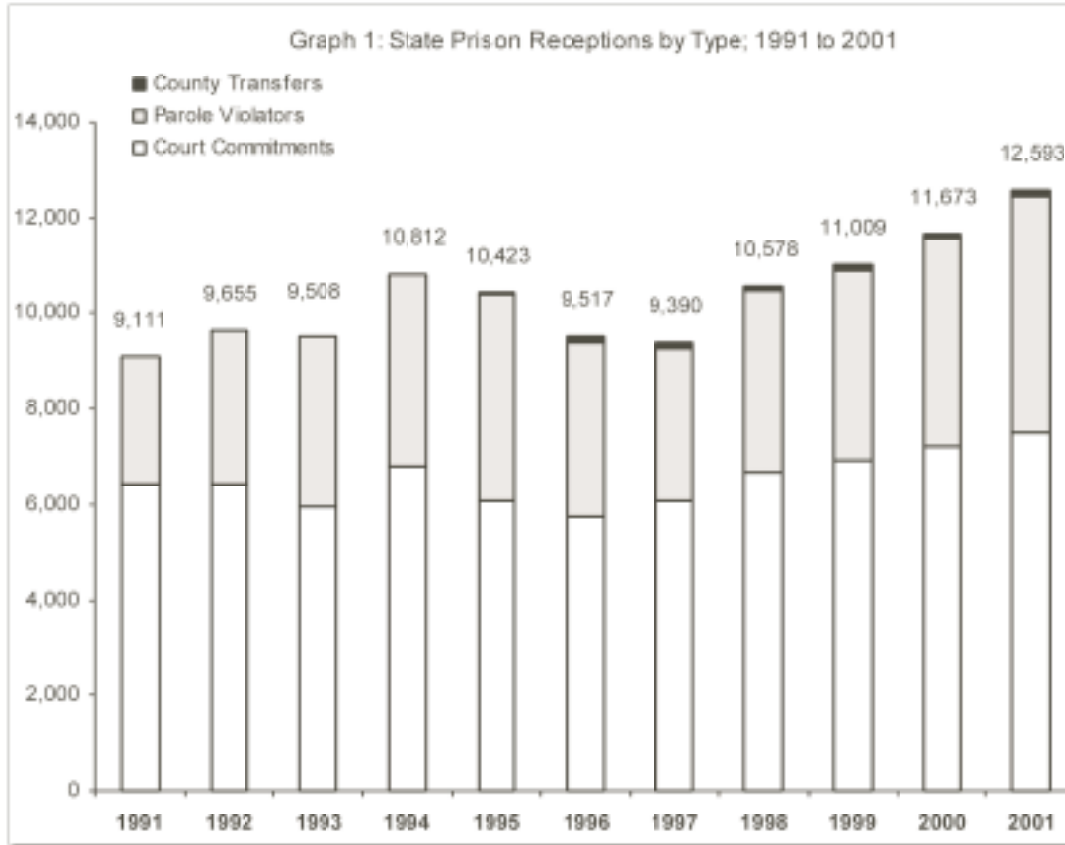
Lifers

New receptions for offenders serving a life sentence increased by 6.9% from 116 in 2000 to 124 in 2001.

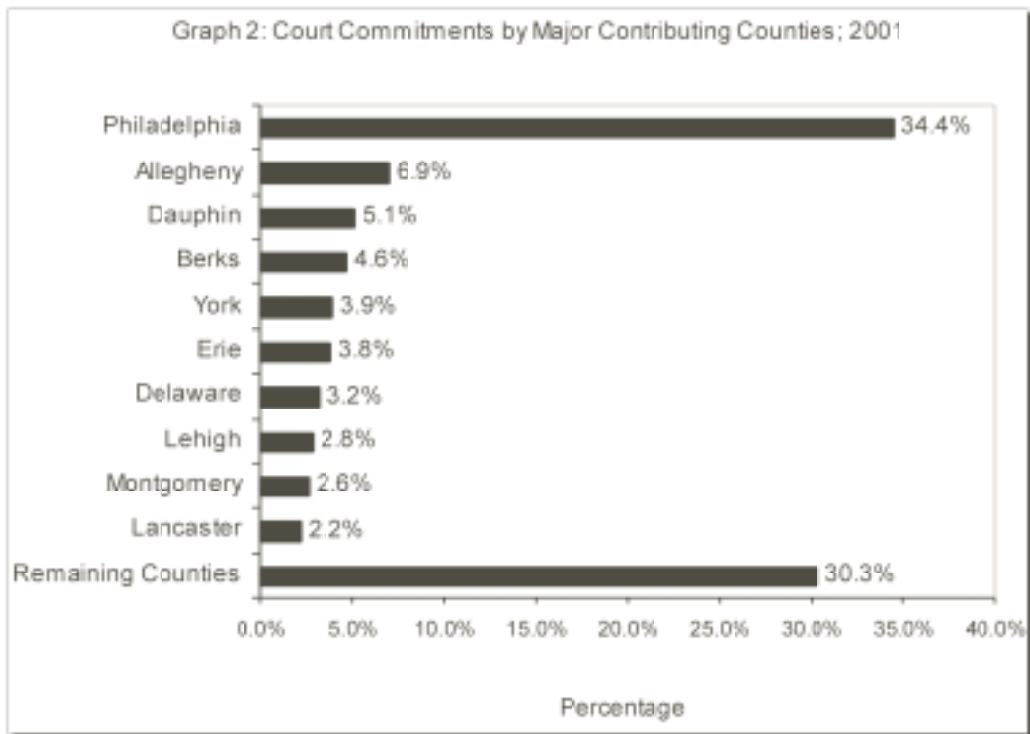

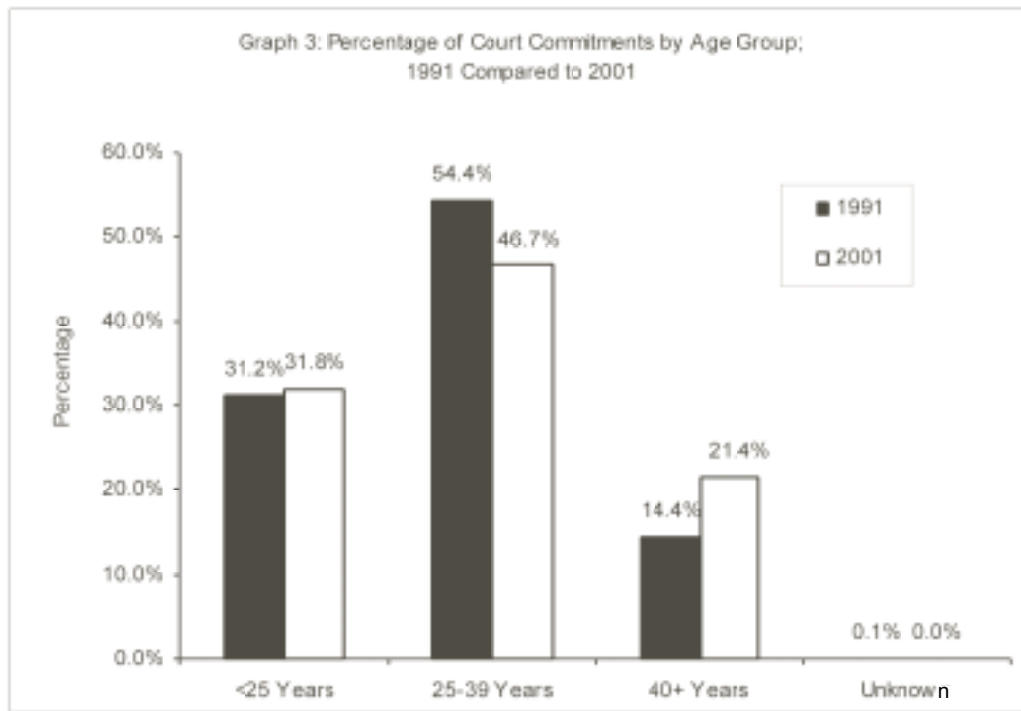

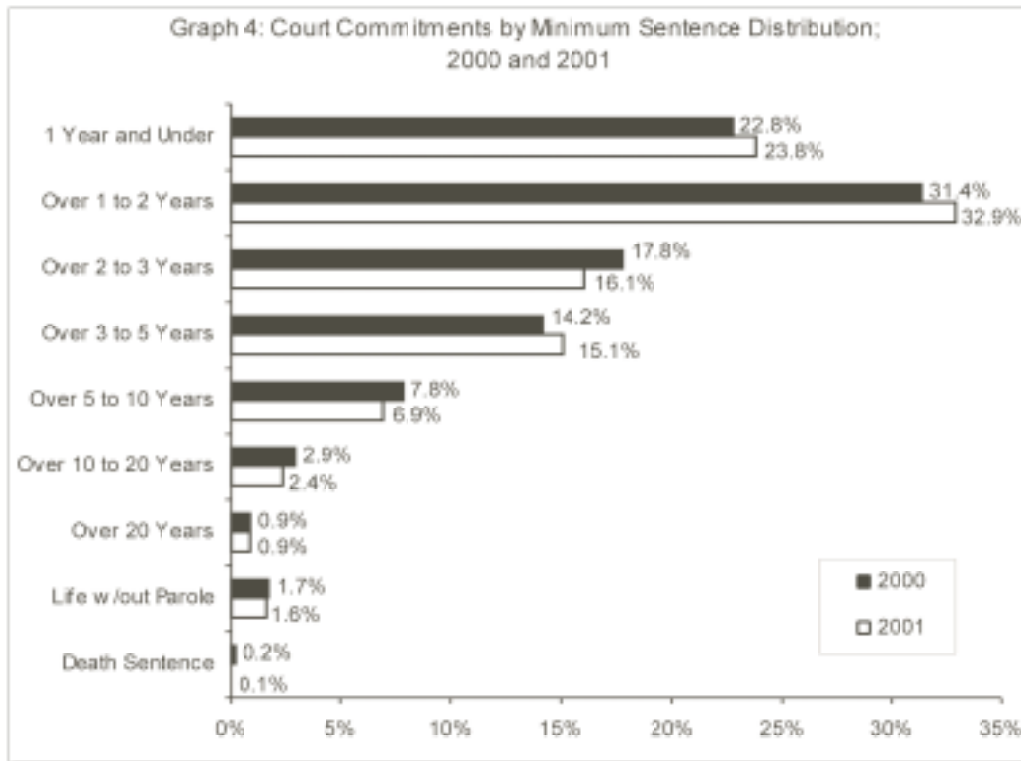

Population

The overall incarceration rate in Pennsylvania increased from 299 per 100,000 state residents in 2000 to 309 per 100,000 in 2001. Incarceration rates for selected counties in the Commonwealth of Pennsylvania increased at varying rates from 2000 to 2001:

The incarceration rate for state prisoners from Philadelphia County increased 5.1% from 965 per 100,000 in 2000 to 1,014 per 100,000 in 2001.

The incarceration rate for state prisoners from Dauphin County increased 6.6% from 589 per 100,000 in 2000 to 628 per 100,000 in 2001.

The incarceration rate for state prisoners from Erie County increased 2.7% from 442 per 100,000 in 2000 to 454 per 100,000 in 2001.

The incarceration rate for state prisoners from Allegheny County remained relatively constant from 292 per 100,000 in 2000 to 290 in 2001.

The number of inmates incarcerated increased 3.4 % from 2000 to 2001. The total inmate population was 36,802 on December 31, 2000 and was 38,067 on December 31, 2001. At the end of 2001, the population was comprised of 82% sentenced offenders and 18% parole violators.

The total number of sentenced offenders increased by 1.8% from 30,718 in 2000 to 31,258 in 2001.

Offenders serving time for Part One and Part Two offenses remained relatively constant. In 2000 there were 20,352 (53.3% of the population) Part One offenders. In 2001 there were 20,127 (52.9% of the population) Part One offenders. In 2000 there were 10,332 (28.1% of the population) Part Two offenders. In 2001 there were 11,106 (29.2% of the population) Part Two offenders.

Parole violator returns increased by 12% from 6,118 in 2000 to 6,834 in 2001.

The Department's single cell capacity increased by 1.9% from 25,690 in 2000 to 26,186 in 2001. In relationship to the offender population in 2001, the Department operated at 145.4% of institutional single cell capacity and 112.2% of multiple occupancy cell capacity.

A demographic breakdown of the Department's inmates indicates that offender age, race, and gender have remained relatively constant over the 2000 to 2001 period:

The average age of a DOC offender in 2001 was 35.0 and the majority of offenders (50.0%) were within the ages of 25-39 years.

The number of inmates under age 18 decreased by 22.4% from 58 in 2000 to 45 in 2001.

In 2001, the majority of DOC offenders were African Americans (54.6%), followed by Caucasians (33.9%), Hispanics (10.8%), and other races (0.7%).

Of the 38,067 offenders in the DOC population as of calendar year-end 2001, 36,362 (95.5%) were males and 1,705 (4.5%) were females.

The number of inmates serving a minimum sentence of 20 or more years (excluding inmates serving life sentences and capital cases) increased by 8.1% from 929 in 2000 to 1,004 in 2001.

The following are characteristics of offenders serving life sentences in the Department :

The number of offenders serving a life sentence increased by 3.4% from 3,627 in 2000 to 3,752 in 2001.

The average age of inmates serving life sentences in 2001 was 40.4 years compared to 39.9 in 2000. The average age for the population of inmates serving life sentences remains higher than the average for the total population (40.4 years versus 35.0 years respectively).

Inmates serving life sentences presently incarcerated in the Department who have served less than 15 years accounted for 61% of the total lifer population in 2000 versus 60% in 2001.

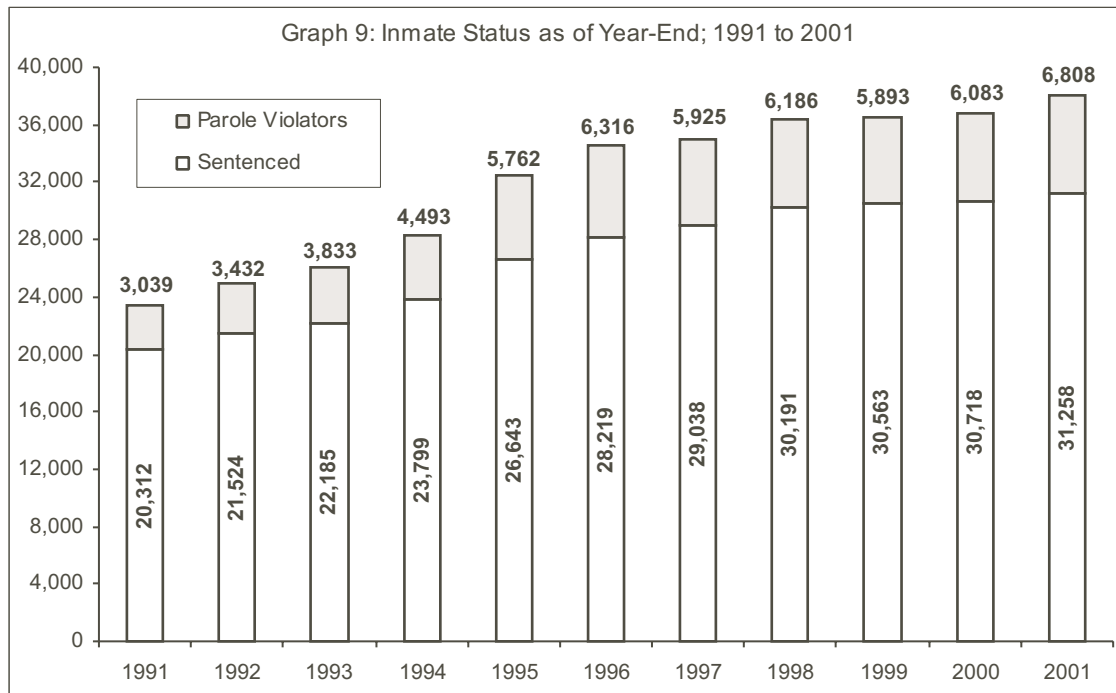

Section IV

Releases



Releases

The total number of inmates released from the Department of Corrections decreased by 2.2% from 10,719 in 2000 to 10,486 in 2001. Of the 2001 total, 27.5% were Part I Offenders, 35.3% were Part II Offenders, and 35.9% were parole violators.

The type of releases from the Department varied for the period 2000 to 2001:

The number of unconditional releases (i.e., expiration of maximum sentence, executions, and court orders) increased 3.8% from 2,990 in 2000 to 3,104 in 2001. Unconditional releases represented 29.6% of total releases in 2001.

The number of conditional releases (i.e., state paroles, county paroles, and reparoles) decreased by 4.9% from 7,326 in 2000 to 6,967 in 2001. Conditional releases represented 66.4% of the total releases in 2001.

The number of deaths increased slightly from 119 in 2000 to 124 in 2001.

The rate of paroles granted by the Pennsylvania Board of Probation and Parole (PBPP) increased from 49.8% in 2000 to 52.5% in 2001. The total number of parole actions decreased 5.5% from 17,396 total actions in 2000 to 16,443 total actions in 2001.

Since December 31, 1994, no inmates serving life sentences were commuted from the Department of Corrections. However, 154 inmates serving life sentences died over this same period.

Between 2000 and 2001, the average time served for Part One offenders released remained relatively constant at 74.4 months.

The average time served for rape increased by 7.8 % from 108.7 months in 2000 to 117.2 months in 2001.

The average time served for robbery decreased by 3.4% from months in 2000 to months in 2001.

The average time served for arson remained relatively constant at 69.4 months in 2000 and 69.8 months in 2001.

The average time served for Part Two offenders released remained the same at 40.8 months for both 2000 and 2001.

The average time served for other sex offenses increased by 19.7% from 56.9 months in 2000 to 68.1 months in 2001.

The average time served for drug offenses decreased by 5.3% from 39.4 months in 2000 to 37.3 months in 2001.

The average time served for drunken driving decreased by 7.5% from 25.2 months in 2000 to 23.3 months in 2001.

There were no breach escapes from institutions in 2001. There have been no breach escapes since 1999.

There have been no walk aways from institutions since 1998.

There were 161 walk aways from community correction centers in 2001. There were 73 walk aways in 2000.

The total number of victim registrations and notifications has changed slightly from 2000 to 2001.

The total number of victims registered with the Department of Corrections has increased slightly. In 2000, 20,790 victims were registered with the Department. In 2001, 20,894 victims were registered with the Department.

The total number of victims notified decreased slightly from 1,835 in 2000 to 1,798 in 2001.

The Department of Corrections' overall personnel complement increased 2.2% from 14,439 filled positions in 2000 to 14,757 filled positions in 2001.

Section VI

Glossary

Capacity: The maximum number of single cell beds a facility was originally designed for, plus beds added or eliminated due to renovations and/or additions.

Capital cases: Inmate found guilty of first degree murder and sentenced by a judge to death by execution.

Commutations: A change of a legal penalty or punishment to a lesser one. A commutation for an inmate serving a life sentence is the establishment of a parole date.

Conditional release: The release of an inmate from the Department of Corrections to another supervising authority. This method of release includes the following types:

State Parole: When an inmate is released to the community and is supervised by the Pennsylvania Board of Probation and Parole.

County Parole: When an inmate is released to the community and is supervised by the county probation/parole department.

Reparoled (State): When an inmate is paroled from a state correctional facility, returned to the Department of Corrections for a parole violation, serves time in the institution, and is again released to the community under supervision of the Pennsylvania Board of Probation and Parole.

County transfers: When an inmate serving a county sentence is transferred to the Department of Corrections. The reason for the transfer could be for security, medical, or mental health reasons.

Court Commitments: A commitment imposed by a court sentencing an individual to confinement in a state correctional facility.

Detentioners: An inmate who has not been sentenced to a Pennsylvania state correctional facility, but who is being housed in a Pennsylvania state correctional facility at the request of another jurisdiction such as a county, another state, or the federal government.

Escape: The intentional act of an inmate to leave the custody of the Department of Corrections. The act of escape includes the following types:

Breach escape: When an inmate, in the process of intentionally leaving the the custody of the Department of Corrections, compromises the security perimeter of the facility.

Walk away escape: When an inmate intentionally leaves the custody of the DOC while on an authorized release or furlough (i.e., work detail, medical treatment, educational release, etc.). A walk away, as opposed to a breach escape, does not compromise the security perimeter of the facility as it occurs outside the security perimeter (i.e., wall, fence, etc.).

Incarceration rate: The number of state sentenced inmates incarcerated per 100,000 Pennsylvania residents.

Lifer: An individual with a minimum and maximum sentence of natural life.

Minimum sentence: The minimum amount of time imposed by the court that an inmate must serve before being eligible for release from prison. This sentence cannot exceed one-half of the maximum sentence under the Pennsylvania statute.

Maximum sentence: The maximum amount of time spent imposed by the court that an inmate can be required to serve before being released from prison.

Non-recommit action: The release of a parolee who was returned to the department as a possible parole violator. If the return action is not adjudicated as a parole violation, the parolee is re-released to parole.

Offender: Generally refers to an individual who is convicted of an offense but who has not been received by the state by the state prison system. This term is used in the Receptions Section of this report to denote newly admitted individuals.

Parole violators: Persons paroled from prison who violated the terms and/or conditions of their parole. Parole violators are generally classified as technical or convicted violators. Technical violators are recommitted for failure to adhere to the requirements of their parole plan (i.e., non-reporting to agent or program, non-criminal drug violations, etc.), while convicted violators are found guilty of new criminal offenses. A technical/convicted violator is committed for violating conditions of parole in addition to being charged with commission of a new criminal offense.

Part I Offenses: Offenses identified by the Uniform Crime Report which are of a serious nature and are usually reported to law enforcement agencies. Crimes identified as Part I Offenses include: criminal homicide, forcible rape, robbery, assault, burglary, larceny-theft, motor vehicle theft and arson.

Part II Offenses: Offenses not classified as Part I Offense as defined above because they are less serious crimes. Crimes identified as Part II offenses include: fraud, stolen property, forgery, narcotic drugs, and drunken driving.

Reparole: A parole release after a previous parole revocation. The initial parole and subsequent reparole occur during the same sentence.

Sentenced: Inmates who are serving time on court-imposed sentences. (Does not include inmates who are serving time because of parole violations.)

Uniform Crime Report (UCR) Offense Groupings: Offense classifications employed by Pennsylvania's criminal justice system. In order to remain compatible with the Federal Bureau of Investigation, the categories of offense classification utilized are the same as those employed at the national level. The crimes defined in this classification system are grouped as Part I or Part II offenses.

Unconditional release: The means of release for inmates who have either served their maximum sentence or have had their sentences reduced or vacated by the court (e.g., max out, executed, court order, etc.).

Victim comments: Oral and written statements describing the impact of crime on the victim's feelings regarding pre-release of a particular offender.

Victim registration: When crime victims request to be informed as to the status of offenders who perpetrated criminal acts against them or a family member. The registration occurs in the victim input and notification program as administered by the Office of the Victim Advocate.
